

# GTCHS Early College Participant Agreement

Based upon the policies, procedures, and guidelines outlined in the *GTCHS College 101 Handbook for Students and Parents* (including our Early College Agreement with Greenville Technical College), GTCHS encourages all students to take advantage of college course opportunities when they are ready.

Students intending to enroll in college courses and their parents must review the *College 101 Handbook* during registration each semester to ensure that all policies, procedures, and guidelines are understood and agreed to/accepted.

While students (and their parents) must understand and agree to all of the policies, procedure, and guidelines stated in the *College 101 Handbook*, it is of the utmost importance that students and parents understand and agree to the following for participation in the Early College Program at GTCHS:

- \_\_\_\_\_ Questions/concerns will be addressed through GTCHS and never directly through GTC.
- \_\_\_\_\_ Stated course maximums exist based upon grade-level and no exceptions will be granted by GTCHS or GTC.
- \_\_\_\_\_ Ineligibility of GTCHS students for online, cohort, and honors courses. (Honors courses may only be taken if accepted into the GTC Honors Program.)
- \_\_\_\_\_ Ineligibility of GTCHS students for summer courses until *after* the completion of the 10<sup>th</sup> grade year.
- \_\_\_\_\_ Adherence to all enrollment, academic, and fee provisions and guidelines.
- \_\_\_\_\_ All eligibility requirements must be met for acceptance and enrollment into the Early College Program; there are no exceptions.
- \_\_\_\_\_ Enrollment is conducted through GTCHS School Counseling Department. Placement testing and ALL accurately completed enrollment forms are due by stated deadlines. No exceptions to the deadlines.
- \_\_\_\_\_ Adherence to all enrollment, academics, and textbooks/access codes, & supplies guidelines.
- \_\_\_\_\_ Adherence to the policies regarding college course Withdrawal and Failure.
- \_\_\_\_\_ Academic Advising is conducted through GTCHS School Counseling Department and all course selection policies will be followed when completing college course enrollment.
- \_\_\_\_\_ No exceptions will be granted by GTC or GTCHS regarding: Course Maximums, Online/Cohort Course Eligibility, Summer Course Eligibility, Taking Maymester/May Mini-mester courses, and fulfilling ALL Eligibility Requirements.
- \_\_\_\_\_ Adherence to all policies regarding College Seminar Attendance Policy, Summer Courses, Other Campuses, After-school/Evening Courses, Senior Project/Financial Literacy, and Advisory Period.
